COMMITTEES UPDATES

ADVOCACY

This committee works with all levels of government, and with NGO partners to:

- Strengthen relationships with decision makers and advance initiatives that inform legislation and policy on elder abuse prevention.
- Develop awareness of emerging issues.
- Ensure that addressing elder abuse and neglect is a priority of government and that older adults' voices are represented in public policy.

AWARENESS AND EDUCATION

With the help of this committee, CNPEA is:

- Engaging with the Canada School of Public Service about co-developing an ageism curriculum for public servants.
- Providing EA expertise for a project between St.
 Clair College, the University of Windsor and the VAW Coordinating Committee Windsor-Essex on training modules specific to GBV/IPV.
- Preparing to develop short multilingual videos on financial abuse. Advisory Committee recruitment will begin Fall-Winter 2025.
- Contributing to the cnpea.ca website redesign project. The Committee oversaw a critical review of resources and materials currently housed on cnpea.ca.

CAPACITY BUILDING

This committee's mission is to support Goal 2 of Future Us: Establish and support elder abuse prevention networks at local, regional and national levels. It also works to foster collaboration with multi-sectoral organizations to mobilize over key initiatives in support of elder abuse prevention.

FUND DEVELOPMENT

- Supports and monitors CNPEA's fundraising efforts, across various avenues (grants, sponsorships, donations).
- In Spring 2025 the Committee assisted with the hiring of a Fund Development Manager, Brooke Eby, who will develop and implement a multi-pronged Fund Development Plan.

GOVERNANCE

The Governance Committee oversees our Board of Directors and staff in their role and responsibilities. It is responsible for overseeing board policies and ensuring good governance and HR practices, adherence to legal and financial requirements, and alignment with CNPEA's Strategic Plan.



SPOTLIGHT:

Collaborate for Change: Dementia-Aware Responses to Abuse in Later Life

Summary

An online symposium focused on enhancing coordinated support of older victims of elder abuse, family violence, and gender-based violence, particularly when they are living with dementia or experiencing cognitive impairment.

This symposium aimed to:

- raise awareness of successful collaborative intervention team models across sectors to assist older adults who have experienced violence, abuse or neglect;
- illustrate the roles that support services and law enforcement can play in assisting older victims by being trained to detect ageism, avoid ableism, and understand seniors' needs better;
- Examine best practices to provide safe, respectful, trauma -and violence- informed services and appropriate support.

What is the Wildflower Way?


The Wildflower Way is a suite of tools designed to support professionals and leaders in human services to integrate services for older women who have experienced gender-based violence (GBV) into broader equity efforts through relational, trauma -and violence- informed policy and practice.

The Wildflower Way is both a narrative strategy and a practical guide for nurturing this growth, offering a path toward sustainability, healing, and genuine systemic change in human services.

Upcoming: Framework and Tools:

The Wildflower guide will provide context and strategy to support implementation of the following tools:

- An Organizational Assessment to assess current state of response and priority areas
- A Self-Reflection Tool to support integration of trauma -and violence- informed (TVI) principles into practice.
- A GBV Primer: a knowledge check for professionals
- **Infographics** that expand on concepts introduced in the guide.



- The WAGE Canada grant that funds the Stop GBV55+ project (now Wildflower Way), and a smaller grant from Justice Canada for Victims and Survivors of Crime Week, allowed CNPEA to pursue exciting, meaningful work again this year.
- A generous donation from Home Equity Bank will help CNPEA develop a new project focused on financial abuse prevention this coming year.
- Since our revenue exceeded \$200,000 this year, for the first time,
 CNPEA completed a full audit of our financials, carried out by accounting firm Reid Hurst Nagy.
- Given our excess cash position, \$50,000 were invested in a high interest fixed term deposit as a reserve fund.

CNPEA is currently in steady financial standing. We continue to regularly pursue relevant project funding while also expanding and strengthening our fund development efforts to diversify CNPEA's revenue sources and guarantee our stability and longevity.
